In all such purchases, sales or trades, SAMTRADE FX is authorized to follow Attorney-In-Fact's instructions in every respect and Attorney-in-Fact is authorized to act for the Client with the same force and effect as Client might do with respect to such purchase, sales or trades and all things necessary or incidental to the furtherance of such purchases, sales or trades. SAMTRADE FX is directed to make available to Attorney-In-Fact a copy of all statements that SAMTRADE FX makes available to Client concerning Client's account including but not limited to monthly statements, confirmations and purchase and sale agreements. Client hereby ratifies and confirms any and all transactions with SAMTRADE FX heretofore and hereafter made by Attorney-In-Fact for Customer's account. **Attorney-In-Fact is not authorized to withdraw from Client's account any monies, securities or any property either in Client's name or otherwise unless such withdrawal or payment is specifically authorized in writing by Client.**

This Power of Attorney shall remain in full force and effect until SAMTRADE FX receives from Client written notification of Client's revocation thereof. Client understands that SAMTRADE FX is in no way responsible for any loss to Client occasioned by actions of the individual or organization named above and that SAMTRADE FX does not, by implication or otherwise, endorse the operation or methods of such individual or organization. The below said undersigned, hereby authorize SAMTRADE FX to debit corresponding said account a transaction fee detailed below and agreed between the undersigned and name of Attorney-In-Fact. The undersigned hereby agrees to indemnify and hold SAMTRADE FX harmless to the full extent permitted by law from any and all losses and/or liabilities resulting from stop losses and payments to Attorney-In-Fact of the below-described fees, and agrees that the undersigned's sole resource for any disputes, loss or miscalculations of same, if any, is to resolve the matter with the Attorney-In-Fact.
